FSC issues the Financial Services (Funeral Scheme Management) (Amendment) Rules 2021

The Financial Services Commission, Mauritius (the "FSC") has issued the <u>Financial Services (Funeral Scheme Management) (Amendment) Rules 2021</u> on 04 September 2021. The Funeral Scheme Management Business has, since 01 October 2016, become a regulated financial business activity under the Financial Services Act 2007 and is governed by the Financial Services (Funeral Scheme Management) Rules 2016 ("FSM Rules").
