INTRODUCTION

Pursuant to section 6(j) of the Financial Services Act 2007, one of the functions of the Commission is to "<u>collect</u>, <u>compile</u>, <u>publish</u> and <u>disseminate statistics</u> in respect of the financial services and global business sectors"



IMF SDDS / IMF SDDS PLUS

Mauritius graduated in February 2012 from the IMF General Data Dissemination System (GDDS) to the Special Data Dissemination Standard (SDDS).

The Government of Mauritius has expressed interest to adhere to the SDDS Plus, which is the third and the highest tier of the IMF's data standards initiatives



DIMENSIONS OF DATA DISSEMINATION

As per the IMF Special Data Dissemination Standard (SDDS), there are four dimensions for data dissemination:

- a. The data: Coverage, Periodicity, and Timeliness;
- b. Access by the Public;
- c. **Integrity** of the disseminated data; and
- d. Quality of the disseminated data.









The **Total Assets** for the financial services sector (*excluding Companies holding a Category 1 Global Business Licence and Insurers*) reached **MUR 52 bn in 2020**.

The **Total Income** generated by the entities in 2020 amounted to **MUR 8.6 bn** which represented **an increase of 13%** over the previous year.



The aggregate Profit after Tax for the non-banking financial services sector (excluding Companies holding a Category 1 Global Business Licence) reached MUR 1.2 bn in 2020 compared to MUR 1.5 bn in 2019.

Total Assets for GBC 1s amounted to USD 516 billion in 2020.



Total Assets of Corporate and Trust Service Providers amounted to USD 326 m in 2020 representing **an increase of 17%** over the previous year.

Total Income of **Corporate and Trust Service Providers** witnessed **an increase of 9%**, going up from USD 281 m in 2019 to USD 306 m in 2020.

Profits reported by **Corporate and Trust Service Providers**, in 2020 stood at USD 45.7 m as compared to USD 45 m in 2019 (an increase of 2%).



Gross Premium received for **Long-Term Insurance Business** stood at MUR 10.5 bn in 2020 compared to MUR 10.7 bn in 2019 (a decline of 2%).

Total Assets of companies in the **Long-Term Insurance** sector stood at MUR 87.5 bn in 2020 compared to MUR 84.9 bn in 2019 (a growth of 3%).

For **General Insurance Business**, gross premium stood at MUR 11.1 bn in 2020 compared to MUR 10.3 bn in 2019 (an increase of 8%).

For companies in the **General Insurance** sector, **Total Assets** stood at MUR 21.2 bn in 2020 compared to MUR 20.1 bn in 2019 (an increase of 6%).



Total (direct) **employment** in the Financial Services sector in 2020 amounts to 9,290


