### Privacy Policy for International Organization of Securities Commissions ("IOSCO") Event

#### a. Introduction

The Financial Services Commission, Mauritius ("FSC Mauritius") values the privacy and confidentiality of the participants in IOSCO event in compliance with the applicable laws on data protection. Please read this privacy policy carefully to understand our practices regarding your privacy.

#### b. Information Collection

Personal Information: For the purpose of the IOSCO Africa/Middle-East Regional Committee ("AMERC") Plenary Meeting and AMERC Public Conference, we may collect, store, use, transfer locally or abroad and erase your personal information, representation, visa information, accompanying persons data, flight details, social events, accommodation and any other information you provide during the event. Whether or not by automated means, we will only collect and process such information with your explicit consent and in accordance with applicable laws and regulations.

#### c. Purpose of the Collected Data

We will use the collected information during the event solely for conducting and facilitating the event. Moreover, we may communicate with you before, during, and after the event. This may include sending event reminders, sharing relevant documents or information, and addressing any follow-up questions or inquiries. During an IOSCO event, photographs and/or audio-visual recordings might be taken and/or live-streamed.

These photos and videos may be published on the website of FSC Mauritius, social media pages, and the online platforms of the co-organizers. They may also be recorded and utilized in various media formats including; press releases of the FSC Mauritius, publications and social networks pertaining to a specific event or for broader institutional purposes, as well as for activities carried out by the FSC Mauritius. By attending such event, you acknowledge and agree that you may appear in publicly available photos and/or videos as described above. However if you do not wish your image to be taken, please let us know when you register.

## d. Authorised Disclosure

The FSC Mauritius may disclose the confidential information under certain circumstances to:

- Co-organizers of the event as reasonably necessary for the management and organization of the specific event for which you registered;
- Third-party service providers assisting the FSC Mauritius with the specific event, subject to contractually agreed conditions of confidentiality and security; or

• Other third-parties for which you consent to disclose in connection with the specific event. The information that is already in the public domain or received from a third party is not within the scope of this policy; or If required by law

## e. Data Security

We prioritize the security and protection of your personal information. To ensure this, we employ suitable technical and organizational safeguards to prevent unauthorized access, disclosure, alteration, or destruction of your data.

# f. Confidentiality

All employees and third-party service providers who have access to your personal information are required to keep it confidential and use it solely for the purposes outlined in this Privacy Policy. The FSC Mauritius agrees to maintain the confidentiality of such information and to use it only for the purposes of this event. The FSC Mauritius would take reasonable measures to protect the information from unauthorised access or disclosure.
