FSC Rules made by the Financial Services Commission under section 93 of the Financial Services Act 2007

1. Citation

These Rules may be cited as the Financial Services (Consolidated Licensing and Fees) (Amendment No. 2) Rules 2016.

2. Interpretation

In these rules -

"principal Rules" means the Financial Services (Consolidated Licensing and Fees) Rules 2008.

3. The principal Rules amended

The First Schedule to the principal Rules is amended, in PART I—
