The Financial Services Commission, Mauritius (the “FSC”) wishes to alert the public on **FX Core/ FxCORE**.

The FSC has recently been made aware that an entity under the name of **FX Core/ FxCORE** was purporting to be owned by **EFG Core Business Ltd** and was soliciting clients using a trading platform initially available on its website: <http://fxcore.net/about-us/about-fxcore>. A snapshot of the statement as it appeared earlier on its website is enclosed for your information with this Alert.

The FSC wishes to draw the attention of the public that the Global Business Licence of **EFG Core Business Ltd**, bearing licence number C110009329, has lapsed pursuant to Rule 14 of the Financial Services (Consolidated Licensing and Fees) Rules 2008.

The FSC urges the public to exercise extreme caution with respect to **FX Core/ FxCORE**.
