



## FINANCIAL SERVICES COMMISSION

### REGISTRATION OF SUPPLIERS

The Financial Services Commission (FSC) invites potential suppliers holding a valid trading license, as applicable, to register for the provision during 2009 of goods, other services or works, or consultancy services as described below with the Financial Services Commission.

#### **Goods, other services or works, or consultancy services**

Air Freight Services, Air Tickets, Cleaning Services, Cleaning Solutions (Detergents), Computer Stationery (including Continuous Stationery), Courier Services, Diaries, Electrical Equipment & Services, Envelopes, Medical Insurance, Insurance Covers (Fire and Allied Perils, Electronic Equipment, Public Liability, Group Personal Accident), Office Equipment (Fax Machine, Photocopy Machine, Shredders, Binders, etc.), Office Furniture, Office Stationery (pens, pencils, eraser, punch, stapler, box file, paper (A4, A3), etc.), IT Hardware (PC, Servers, Printers, UPS, Scanner, Cabling, etc.), Printing and Publishing services, Transport facilities, Security Services, Taxi Services, Water Proofing, Building Maintenance and Repairs, Air Conditioners, Plastic Bags, Florist, Security, Pest Control, Mess Items (Milk, Tea, Sugar, Biscuits, Juice, Paper Plates, Tissue Paper, etc.), IT Solution Providers, Plumbing, Electrical, Carpentry, etc., Hardware Supplies, IT Accessories (CD, USB drive, DVD, Backup Tapes, Recording Tapes, Toners, Data Cables, Electrical Cables, etc.), Uniforms, Protective Apparel, Gardening Services, Medical Supplies for First Aid Box (Panadol, Wound Plast, etc.), Hygiene Suppliers (Sanitax Bin, Liquid Soap, Jumbo Tissue Rolls, etc.).

All applications must be made on the Supplier Registration Form which is obtainable from either the Reception Desk at the FSC House, Ebene or [www.fscmauritius.org](http://www.fscmauritius.org).

The Forms duly filled-in, signed, placed in a sealed-envelope marked "Registration of Suppliers" on the top right-hand corner, and addressed to the Secretary, Procurement Committee, 54 Cybercity, Ebene, must be deposited in the tender box at the Reception, FSC House, by 11:30 hours on 15 April 2009.

#### **Applicants are invited to take note of the following:**

- (i) price of items offered need not be submitted at this stage;
- (ii) FSC has no contractual obligations towards any potential applicant whomsoever;
- (iii) this exercise shall not entitle applicants to become exclusive suppliers of the FSC; and
- (iv) FSC reserves the right to proceed with tender procedures at any time regardless of the outcome of this registration exercise.
