**1. Scope of Contract:**

In view of protecting its information system from failures, disasters and threats coming from all sides in growing numbers and complexity, the Financial Services Commission is upgrading its computer infrastructure. The aim is to improve substantially service performance and availability, security and ease of recovery in case of failure. The Financial Services Commission requires computing devices and an end to end solution that can support the high availability, scalability and manageability needs of a complex data centre environment. The Server and Storage technology to be implemented will be expected to host the Commission's applications for the next 5 to 10 years.

- a. Consolidation of server and storage infrastructure
- b. Consolidation of Microsoft infrastructure over VMWare technology
- c. Consolidation of Antivirus / Antispam infrastructure
- d. Disaster recovery implementation for all critical services identified.
- e. Installation and Commissioning of UPS systems
- f. Quality Assurance / transfer of knowledge
