Review of fees and renewal of licences

1. Quantum of annual fees and due date for renewal of licences

The Commission hereby informs its Registered/Authorised/Approved persons, (“licensees”) that, following National Budget 2025/26 announcement, consultations were undertaken in relation to the above matter, based on which, it has concluded its review of fees. This review has been implemented through amendments to the Financial Services (Consolidated Licensing and Fees) Rules. The amended Rules were gazetted on 30 June 2026 and is effective as from 01 July 2026.

The Financial Services Commission, Mauritius (the “FSC”) hereby reminds all licensees who are required to pay their annual fees that the due date for the payment of license fees has been extended to 30 September 2026 as mentioned in our Circular Letter CL20260626. All licensees are encouraged to take note of these changes and ensure timely compliance with the updated fee structure.

The Financial Services (Consolidated Licensing and Fees) (Amendment) Rules 2026 can be accessed on the FSC’s official website. Licensees may also consult the published document to obtain full details of the amendments and their implications.

2. FSC One Platform

Licensees will be able to pay their applicable annual fees, as well as the fees of their clients who are licensees of FSC by using the FSC One Platform as from 01 July 2026, by way of *Automatic Payment Instruction*. Management Companies which have *Deposit Accounts* with the FSC, will also be able to pay their fees from their respective *Deposit Accounts*. Licensees can access the online platform as follows:

- ii. Licensees are reminded that they need to be registered on the online platform to be able to use the system.
- iii. Please select the following tabs under the Renewals Payment module, as applicable.
 - Management Company Fees
 - Global Business and Authorised Company Fees
 - Global Business – Variable Fees
 - Domestic Fees
 - Domestic – Variable Fees
 - Sub-Funds, Cells and Share Class

3. Alternative arrangements to the FSC One Platform

Should licensees encounter issues in renewing licenses through the FSCOne Platform by 30 September 2026, they may use the alternative method established by the FSC which will allow prompt renewal of licences, as follows:

- Ensure adequate funds have been transferred to the relevant FSC bank account by 30 September 2026 to cater for the renewals. FSC bank details are as per **Annex 1**; and
- Send an excel copy of the relevant list(s) for which the payment is being made to the following email address: fsc1finance@fscmauritius.org.

4. Other important information

Insurance companies are kindly requested to bring the contents of this Circular Letter to the attention of intermediaries working with them.
