

Mr Oliver Garrett-Jones, Head of Blockchain Policy, OECD



Mr Oliver Garrett-Jones is the Head of Blockchain Policy at the OECD, where he leads a number of initiatives to support governments and public institutions responding to the transformative impacts of decentralised technologies. Prior to this, Oliver held a number of roles in economic diplomacy and international cooperation on business and finance issues at the OECD and in the Australian Government, including as Counsellor to the OECD's Director for Financial and Enterprise Affairs, as an Australian Treasury representative to Europe, and a member of the Australian Government's G20 Policy Task Force. He holds a Master of Public Policy (International Policy) from the Australian National University and a Master of Commerce (Management) from the University of New South Wales.

Mr Colby Mangels, Adviser, Centre for Tax Policy and Administration, OECD



Mr Colby Mangels is a Tax Policy Advisor at the Organisation for Economic Cooperation and Development's (OECD) Centre for Tax Policy, focusing on the development of the Crypto-Asset Reporting Framework and amendments to the Common Reporting Standard. Previously, Colby spent two years working as a Policy Analyst at the Financial Action Task Force (FATF), where he helped design and draft the FATF's international anti-money laundering methodology on Virtual Assets and Virtual Asset Service Providers. In addition, Colby previously worked at the OECD's Global Forum on Tax, where he conducted peer review evaluations of jurisdictions in relation to the international standards on the Common Reporting Standard and the exchange of information on request.

Prior to joining the OECD and the FATF, Colby worked for several years as an attorney at the Washington, D.C. headquarters of the Office of the Comptroller of the Currency (OCC), where he specialised in U.S. bank regulatory issues, including federal licensing and examination requirements, as well as Dodd-Frank regulatory implementation. Colby obtained a Juris Doctor degree from UC Berkeley Law and is an active member of the District of Columbia Bar Association. Prior to law school, Colby was a Fulbright Scholar researching anti-money laundering issues in Switzerland and worked as a parliamentary staff member in the German

Parliament. Colby is originally from Georgia and obtained his undergraduate degree from the Georgia Institute of Technology (Georgia Tech).
